By signing and sending the entry form I confirm that none of the listed persons is member in a competitive breed club for the same breed or in a cynologic association which is neither a VDH or FCI member. By transfer of the entry form I accept the decision of the judge.

I am aware of that the personal data in the entry form is handled and forwarded to the responsible regional group and the SV for the purposes of registration and realization of the character assessment. Publication of the results takes place in the publications of the club and the homepage of the hosting local group, the responsible regional group and the online data base "SV DOxS".

Furthermore, we would like to point out that during the event photos are taken for the purpose of reporting, public relations and documentation. Those photos will be published in the club publications and web pages of the organizing local group. Legality is given by Art. 6 Abs. 1 Lit. b und f DSGVO and the "Kunsturhebergesetz".
